DESCRIPTION

Brick & Mortar Cleaner is a proprietary formulation of special acids and cleaners which effectively removes rust, mildew, algae, smoke, and creosote stains. It is a safer alternative to Muriatic acid with a special additive to reduce fumes and burns that are normally associated with Muriatic acid.

USES

Use Brick & Mortar Cleaner to clean both brick and masonry surfaces of rust, mildew, algae, smoke, and creosote stains.

ADVANTAGES

- Safer to use than muriatic acid
- No harsh fumes
- Not likely to cause acid burns
- Cleans as well as muriatic acid

DIRECTIONS FOR USE

Weather Conditions: Do not apply to frozen or frost covered surfaces. Beware of wind drift. **Limitations**: **Do not use on limestone**! This product will dissolve limestone.

Surface Preparation: Always test in an inconspicuous area before using to ensure desired results. Protect foliage and all applicable surrounding areas including wood, glass, aluminum, asphalt roofing, vinyl siding, and painted surfaces. Beware of wind drift.

Dilution: Dilute Brick & Mortar Cleaner 4:1 with water. For difficult to remove stains this product can be used full strength.

Caution: When diluting product with water, slowly add the product to the water while stirring. Never add water to the product.

APPLICATION

Brush surfaces to be cleaned with a stiff brush to remove loose particles. Wet all surfaces to be cleaned with liberal amounts of water. Flood the surface with Brick & Mortar Cleaner taking care that the product does not run down onto non-targeted areas. Using a stiff, non-metal brush, scrub the area thoroughly, allowing the cleaning solution to remain on the area for three to five minutes. Completely rinse the treated

area using a garden hose with adjustable nozzle, or pressure washer set at 400-600 psi. When rinsing, use as much water as possible. To avoid streaking rinse from the bottom up. For severely stained areas it may be necessary to repeat the application of Brick & Mortar

Coverage: Coverage rates will typically range from 300-700 sq. feet per gallon depending upon dilution ratio, surface texture, and porosity.

CLEAN UP

Cleaner.

Thoroughly rinse spray equipment with clean water.

CAUTIONS

Keep out of reach of children. Keep container closed. Eye irritant.

Avoid contact with eyes, mucous membranes & prolonged contact with skin. The use of chemical splash gloves and a NIOSH approved respirator is highly recommended when using this product.
